False sense of security

When you're inside a home and ob-

serve a smoke alarm on the ceiling or wall do you assume it's functional? Or are you comforted by a false sense of security?

Surveys indicate, 96% of homes in the United States have smoke alarms, but working smoke alarm.

One of the primary goals of a smoke alarm is to alert people to a fire when they are sleeping. In the past, it was the industry from code updates to point thought that smoke detectors should be placed only outside the bedrooms, but tests have shown, that in many cases fires were able to grow to big to escape by the time smoke tripped the alarm.

> Placement of smoke alarms is recommended in attached garages, on each level of the home and inside each bedroom above the door. See local city jurisdictions for further information.

Every home should have functioning smoke alarms. Batteries should be checked twice yearly and the alarm tested monthly. Smoke alarms with no batteries are the same as no alarm at all.

One of the best activities during the summer is swimming. The water is so refreshing on a hot day. It's a great low impact way to get some exercise and it's so much fun splashing around, you won't even realize how many calories you've burned.

With all that fun comes a few safety reminders around the water.

- Never leave children unattended.
- No diving in unfamiliar waters.
- Watch out for the 'toos' too tired, too cold, too much sun and too far from safety.
- Know your swimming limits and stay within them.

According to the National Safety Council, drowning is the second leading cause of death from unintentional injuries from ages 5 to 24 years of age and the leading cause of death from unintentional injuries for all ages.

### Don't loose your cool

With the warmer weather fast upon us.

Here are some tips to keep your home comfortable during the summer heat.

- Keep shades closed during the heat of the day.
- Attic fans can help keep attic temps down. Ideally, the attic air is the same temp as the outside air. I've entered attics in the summer with temps as high as 120 degrees. Ventilation and insulation are both critical factors to keeping the heat out.
- Keep your air conditioners running at peak efficiency. Compressor units should be clear of all obstructions. Replace damaged insulation on refrigerant lines.
- Plant trees and shrubs to shade your air conditioner, but keep them 18"away, so they don't block vents.
- Make sure the ducts in your airconditioning system are properly sealed and insulated, especially those that pass through the attic.
